

# EMSWORTH YACHT HARBOUR

## WINTER BOOKING FORM 2019/20

**WINTER ASHORE:** £144/m for up to six months or £160/m with cradle hire, for payment in advance.

- Package includes lifting, jet-wash off, mast step/unstep if required, storage, launch in spring.
- Start date must fall between 1<sup>st</sup> October 2019 and 16<sup>th</sup> December 2020.
- Additional months ashore (beyond six months) will be charged as summer storage ashore.

**WINTER AFLOAT:** from £97/m for up to six months for payment in advance.

- Fully serviced pontoon berth for £97/m for monohull, £115/m for a multihull.
- Offer is valid from 1<sup>st</sup> October 2019 to 31<sup>st</sup> March 2020.
- **Please note:** boat may only stay in marina beyond 31<sup>st</sup> March 2020 subject to agreement with Harbour Manager and will be charged at standard visitor summer berthing rates.

Standing order payment options also available without advanced payment discount.

Electricity ashore and afloat will be metered at cost via prepayment card metering. Please see overleaf for applicable terms and conditions.

*To secure your place ashore or afloat, subject to confirmation of availability, please complete and return the form with a £50 deposit. This is non-refundable should you decide not to come to the marina but will be offset against the winter invoice. Please make cheques payable to Emsworth Yacht Harbour Ltd or call us to book over the phone and pay by credit or debit card.*

# **EMSWORTH YACHT HARBOUR**

## **WINTER VISITOR TERMS AND CONDITIONS**

### **GENERAL:**

All visitors shall be bound by the Berthing and/or Storage Ashore Licence Standard Terms and Conditions. Copies are available in the Harbour Office.

Payment of deposit, booking or arrival in the marina shall imply agreement to these Terms and Conditions.

Storage and Berthing fees are based on the Length Overall (LOA) of the vessel inclusive of any fore and aft projections, temporary or permanent. The Company reserves the right at any time to measure the vessel and charge additional fees if the LOA is greater than the length provided by the owner.

The owner shall ensure that the vessel is fully insured for all risks and liabilities associated with berthing and storage ashore. Casual labour should be covered by the owner's insurance.

It is the owner's responsibility to inform the Harbour Office when a contractor has been engaged to work on their vessel, otherwise access may be refused.

The owner, his regular crew, members of his family and/or any person or company carrying out work on the vessel, with the permission of the Company, must comply with the Company's Site Rules, the Company's Health and Safety Policy and its Environmental Policy. These are available in the Harbour Office

### **WINTER ASHORE:**

Package includes lift and launch, standard jet-wash, optional mast unstep/step and storage ashore for a period of up to 6 months ashore commencing between 1<sup>st</sup> October and 16<sup>th</sup> December. Berthing before lift-out included, berthing after week of launch or 31<sup>st</sup> March not included.

Additional storage ashore after six months shall be charged at applicable published storage rates.

Visitors shall comply with the Site Rules, available in the Harbour Office.

Masts for un-stepping should be prepared so that all sails and boom are removed, electrics disconnected and leads on deck, all running rigging led to the base of the mast and split pin/seizing wire/tape removed from bottle-screws. Sails are not to be unfurled whilst boat is ashore.

Dry sanding of antifouling is not permitted. Ground sheets must be used when cleaning and painting.

No one shall adjust, move or rearrange boat cradles, shores, wedges, pads or props.

Owners' cradles will be inspected for suitability and their use for storage may be refused.

### **WINTER AFLOAT:**

Package includes berthing in the marina for the Winter Season between 1<sup>st</sup> October and 31<sup>st</sup> March.

Berthing for any period outside of the Winter Season shall incur additional berthing charges.

The vessel's owner shall not be entitled to the exclusive use of a specific berth but shall use such berth as is from time to time allocated to him by the Company.

No sewage, oils or petroleum-based products shall be allowed to enter the marina. If an accidental spill occurs the Harbour Office should be informed immediately.

Owners are to inform the Harbour Office if sailing out overnight, with an expected ETA of return.
